

RESOLUTION NO. 02-08-19
ESTABLISHMENT AND MAINTENANCE OF DISTRICT'S
SITE REVOLVING CASH FUNDS

WHEREAS, Section 42810 of the Education Code provides that the governing board of any school district may establish by resolution revolving cash funds for use by the school principals and other administrative officials of the school district; and

WHEREAS, the Board of Education of the Newport-Mesa Unified School District has previously authorized the establishment of a District Revolving Cash Fund; and

WHEREAS, the day-to-day expenditures of an emergency nature can be paid most efficiently from a Site Revolving Cash Fund; and

NOW THEREFORE BE IT RESOLVED, the Board of Education of the Newport-Mesa Unified School District has authorized the custodian of the District Revolving Cash Fund to establish and maintain the following Site Revolving Cash Funds for use by school principals and other administrative officials herein designate:
