- Uniform Complaint Procedure reporting

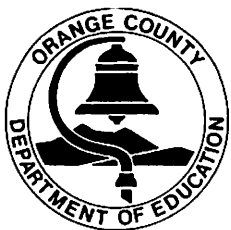

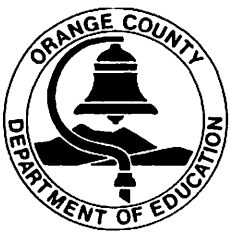
