## Kuta Software Policies


### Security

Through Kuta Works, teachers can view personal information (account and assignment results) for students whom are registered in their courses.

Parents or legal guardians for a student under 18 years of age may request to view, correct, or delete their child's personal information by contacting the teacher for the course. In the event that the teacher has lost access to Kuta Works, a school or district may make a request to Kuta Software LLC to view, correct, or delete the information.

A student may delete their account. After the delete action is taken, the user will no longer be able to use the services. For courses in which the student is enrolled, the teacher will no longer see the student listed and will not be able to see the student's results. Within 7 days of the delete action, the student's personal information (account, registrations, and results) will be deleted from the active server resources. After an additional 35 days, the student's personal information will also be deleted from all rolling backups.

If a student account is inactive for one year, the account information will be automatically deleted. After 35 days, the student's account information will also be deleted from all rolling backups.

Student results will be automatically deleted 21 weeks after the associated course expires. After an additional 35 days, the student results will also be deleted from all rolling backups.

Through Kuta Works, students will see personal information (first and last name) of the teacher for their courses.

A teacher user may delete their account. After the delete action is taken, the user will no longer be able to use the services. Within 7 days of the delete action, the teacher's user profile will be deleted from the active server resources. After an additional 35 days, the teacher's user profile will also be deleted from all rolling backups. A history of Kuta Works seats purchased, transferred, and used will be kept.
